It was agreed to monitor the situation and to review it again next month.</p> <p><u>Update on repairs to the bridge by NCC Highways</u></p> <p>Repairs to the bridge had been completed to a high standard, ahead of time and the Chairman has sent an e-mail of appreciation to Highways. Painting of the white lines from Snorscomb to the bridge, as well as clearing of the grips will be done during either January or February 2017, depending on the weather.</p> <p><u>Overgrown hedges and garden at 1 Long Row Close</u></p> <p>No progress to date. Highways will contact the owners during January to request them to trim and clear the overhanging vegetation.</p> | |
