- 8.3 NCC Highways advised that they are now heading into the Micro Asphalt season. If they are in our area, advance warning signs will be installed and local residents will receive a letter giving full details. Their crews will allow access, although some delays may occur if they require full road closures for the safety of all.

- 8.5 Northamptonshire Fire & Rescue Service have launched a public consultation regarding proposals for the governance of Northamptonshire Fire and Rescue Service to transfer from the Fire Authority which currently sits in Northamptonshire County Council, to the Police and Crime Commissioner, who would therefore become the Police, Fire and Crime Commissioner as the government wants our emergency services to work much more collaboratively and has recently changed the law to allow this to happen.
