	Outstanding Highways repairs	
	The outstanding repairs have not been carried out and it was agreed to chase Highways, for an update.	KN
	Dog fouling	
	It was reported that, apart from the odd incident, this is under control.	
	Damaged dog waste bin	
	It was agreed to replace the damaged bin and to mount it in a slightly higher position, to try to prevent a recurrence of the damage.	
	Inconsiderate parking	
	The Council will continue to monitor the situation and will issue windscreen notices as appropriate.
