10.	The Chairman and Cllr Wilkins reported upon the recent Parish and Town Council's meeting, where various topics were discussed. The minutes from this meeting will be published on the Parish Council website. Everdon PC was able to ask two questions of Highways, who confirmed that painting of the white lines, near the bridge has been		

	scheduled for January or February, but this is weather dependent. In addition Highways have erected temporary signs on Dodford Road, at the junction with the A45, advising that the road is unsuitable for HGV's, which should deter such vehicles from erroneously trying to access Everdon Park Industrial Estate, via this route. Any impact will be reviewed and reported.	
11.	It was reported that the newsletter article and resumption of poo spraying has had a positive effect, with some improvement in certain areas. The situation will be monitored continuously and action will be taken against the offenders.
