3.	<b>Public Open Forum</b> – A member of the public attended to ask for an update on switching off a lamp near to their property which was discussed at the October meeting. The Item is on the agenda (Item 10) and it was confirmed that it is feasible to switch one light off, but as streetlighting has been provided for a number of years the removal of this may lead to safety issues. It was suggested that residents with concerns over the lighting request an impartial assessment from <u>environmentalimprovement.ddc@westnorthants.gov.uk</u> and then any recommended improvements can be made.

8.	Councillor Linfoot said there was little to update. There is a Cyber Fraud Meeting on Thursday 17 <sup>th</sup> November which she will attend. A new Fire Officer, Mark Jones has been appointed.				
9.	It was RESOLVED to offer the contract to HGM LC Hedging and Grass				
	Maintenance Ltd for a three-year term.				
	<b>ACTION:</b> Clerk to inform all the tender contractors of the outcome and to remind				
40	HGM to clear around the Grit bins. After investigating the feasibility of switching one light off the Clerk confirmed it is				
10.	possible and the cost is £80, however, while the provision of streetlighting is not a				
	duty for the Council it has been providing this in the village for many years and				
	the removal of a light may create a safety issue. Having consulted West				
	Northants Environmental Health Manager, it is recommended that affected				

	residents contact environmentalimprovement.ddc@westnorthants.gov.uk to start						
	an investigation and an officer will contact them directly.						
	Another discussion was to install a photocell on the specific light so it could go of						
	between 12-5am, which would cost £220.						
	Action: Councillors Osborne, Wilkins and Cooper will meet on Friday 18 <sup>th</sup>						
	November to assess if there is any obvious remedial action that can be						
	undertaken to this one light and will report back to Council as soon as possible.

Further to Highways information that there is a procurement issue and the Fawsley Road culverts works (postponed three times) will not be undertaken until January 2023 the there is no update on this issue. The Clerk will continue to pursue with Highways and Councillor Frost to get a confirmed date. <b>Action:</b> Clerk to liaise with Highways and Councillor Frost over confirmation of the date.
